MAIN FEATURES

Compliance Library

This is the library of all regulations, policies and guidelines that will be used as reference and for testing of compliance using the Individual Checklist and Department Checklist.

Organization Map

This is where the hierarchy of the organization is configured. This feature is used extensively in the checklist, non-compliance report and for organizing the data in reports.

Governance of Chinese Wall Policy

This module allows maintenance of Watch List, Restricted List, Black-Out List, Deal Team members to ensure compliance of the Chinese Wall policy and to protect the bank against insider trading allegations. Bank employees can submit applications to trade and compliance officers can review the applications and approve or reject the applications.

Deal Team Leaders and Departmental Heads can request for a client to be added to or uplifted from the Watch List and/or Restricted List and/or Black-Out List. The module also supports requests for Crossing Over Chinese Wall and Crossing Back Chinese Wall to ensure transparency when a Deal Team requires outside experts to temporarily join the Deal Team.

Individual Checklist

This is where the individual checklists are published. The system automatically publishes the individual checklist based on the assigned organization units in the compliance library and the assignment of a user to specific organizational units.

Departmental Checklist

This is where the departmental checklists are published. The system automatically publishes the departmental checklist based on the assignment of organization units to specific rules and regulations in the compliance library.

Non-Compliance Report

From the checklists, the compliance officer can identify any non-compliance issues and create a non-compliance report.

Reporting

This function is used to define the report templates that will be used to generate various reports. This function can be used to create reporting templates for example:

1. List of incomplete checklists
2. Departmental overview of reported non-compliance issues
3. Full list of non-compliance issues
4. List of non-compliance issues that has not been resolved
5. Listing of Compliance Library
6. Listing of Compliance Reporting Submission by Departments or Branches

Workflow

The Workflow engine of DYMA RTG allows configuration of the system workflow to match the specific steps of each compliance process of the Bank. If the process steps changes, the system workflow can be changed to match the new process steps.
